

# Terms and Conditions for Blueprint Cruise Event 2019

Life Journeys acts only in the capacity of agent for participants in all matters related to transportation and/or all other related travel services & assumes no responsibility, however caused, for injury, loss or damage to person or property in connection with any service, including but not limited to that resulting directly or indirectly from acts of God, detention, annoyance, delays, or expenses arising from strikes, thefts, pilferage, failure of any means of conveyance to arrive or depart as scheduled, discrepancies or change in transit, over which it has no control. Cost of accommodations & associated services for overnights in route, caused by weather, flight schedules, and other events beyond our control are the responsibility of the passengers. It is understood that there is no liability held by Ron Oyer's Life Journeys, Inc., Sympoz LLC d/b/a Blueprint, and NBC Universal Media, LLC, or any of the foregoing entities' parents, subsidiaries, affiliated companies, officers, directors, agents, employees, licensees, successors and/or assigns thereof (collectively, the "Released Entities"), for any physical, emotional, mental or spiritual injuries incurred by participants before, during or after the trip. This includes loss of life or any bodily harm or injury of any kind at any point in time before, during, or after the Blueprint Cruise Event (defined below) in which you have voluntarily participated. You agree to take full responsibility for attending this event with no expectations of any kind and will except whatever program is being offered and or services as satisfactory given your voluntary monetary contribution toward the attendance of this event. You further agree to hold harmless the Released Entities, of any liabilities both physically or emotionally due to death, bodily harm, physical or emotional injuries while attending the Blueprint Cruise Event. You agree that no liability will be held by any of the Released Entities, if for any reason the author/celebrity/presenter is unable to perform for any reason. You understand that you are voluntarily participating in this Incentive Program (defined below) or Blueprint Cruise Event and are assuming any and all the risks involved or associated with your attendance and participation while onboard any area of the vessel The Nieuw Amsterdam and while off ship during the course of the Cruise time period including without limitation while attending any off ship Blueprint Cruise Event activities. Any disputes arising out of any areas of the Blueprint Cruise Event / sailing will be settled by mediation services according to the laws of the State of California in the County of Orange for Life Journeys and in the County of Los Angeles for all other Released Entities. **On**

**advancement of deposit to this agency, the depositor agrees to be bound by all of the above stated terms & conditions.** You agree that you understand the fact that it is your responsibility to obtain any and all VISA's or entry requirements from your country of origin to the various destinations on this tour. And that you will hold the Released Entities and all other parties free of any liability due to the fact that you cannot enter a country on the itinerary that has been previously provided and published due to lack of proper entry documentation which is the sole responsibility of the passenger. You understand and agree not to hold the Released Entities, in addition to any and all of their subsidiaries liable for any accident, death or health issue arising from any excursion that you buy or take part in and that you take full responsibility for your own involvement. You give permission to the Released Entities to display and promote your image as an attendee of this Blueprint Cruises Event for all promotional, website based and sales purposes.

Additionally, as part of, and in connection with the Blueprint Cruise Event, Life Journey's and/or Blueprint and/or Endemol Shine North America and all related entities ("Event Producer(s)"), will periodically photograph, film and/or otherwise record Blueprint Cruise Event participants during the cruise, and during Blueprint Cruise Event-related excursions for retail, website based, marketing, advertising, production, promotional and publicity purposes. Without any requirement that we compensate you or obtain any additional approvals from you, by participating in the Blueprint Cruise Event, you and the other Blueprint Cruise Event participants for whom you book a reservation, irrevocably: (i) consent to be photographed, filmed and/or otherwise recorded in connection with the event; and, (ii) authorize us to include your name, picture, likeness and/or photographic, video recordings and other visual portrayals of you, as well as voice recordings included with any videos, in photographs, videos, DVDs and any other media that we sell at retail or that we use for marketing, website based, advertising, production, promotional and/or publicity purposes in any and all media now known or hereafter devised without any limitations whatsoever.

In the event that the any Talent associated with this Blueprint Cruise Event are unable to perform due to any cause outside of their control, including but not limited to death, injury or any other force majeure, the cruise will not be cancelled and all passengers will be entitled to a refund of the event fees only. You agree to hold harmless the Released Entities listed above for any travel expenses incurred from the cancellation of this event. This includes all refundable or un-refundable airline travel purchases, hotel purchases, car rentals or any travel expenses purchased as part of the attendance of this event including cruise fares that fall within Life Journeys or Holland America's Cancellation Policy guidelines. You agree to take full responsibility for your registration/booking and all deposits and fares.

**NON-US CITIZENS:** You agree to not hold the Released Entities and/or any of their clients responsible for acquiring or attaining information for your travels in regards to local embassies or custom regulations in the U.S.A. including your country of origin. All passengers will assume full financial responsibility for any additional costs or monetary losses due to passenger's inability to meet and determine if any additional VISA/ENTRY requirements are needed for any of the countries visited on your cruise itinerary.

### **Blueprint Reservation Incentive Program ("Incentive Program")**

The VIP Event Pass is limited to the first one hundred (100) Qualified Bookings. VIP Event Pass offer will be fulfilled on a first-come, first-served basis. The VIP Event Pass offer ends October 25, 2019 or when the VIP Event Pass offer has been depleted, whichever comes first. Qualified Booking must be made through [www.myblueprint.com](http://www.myblueprint.com) (the "**Website**"). One (1) Qualified Booking per Eligible Participant will result in one (1) VIP Event Pass. The VIP Event Pass offer is presented by Sympoz LLC d/b/a Blueprint and NBC Universal Media, LLC. ("**Company**") and is subject to the following terms & conditions:

1. **Eligibility:** Participant must be at least twenty-one (21) years of age or older, to be eligible to receive the VIP Event Pass. Employees of Company, and Life Journeys ("**Cruise Operator/Co-Producer**") together with the immediate family members and/or those living in the same household of such persons are not eligible to receive the VIP Event Pass. "**Household Members**" shall mean those people who share the same residence at least three months a year; and "**Immediate Family Members**" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. 2. **Qualified Booking:** To make a Qualified Booking, the Participant must visit the Website and follow the on-screen instructions to book either a single, double, triple or quad stateroom in conjunction with paying the required deposit for such stateroom. Failure to provide the necessary deposit, failure for such deposit to clear, cancellation of reservation or revocation of reservation due to failure to pay full ticket price by the payment deadline will result in forfeiture of the VIP Event Pass.
3. **VIP Event Pass Offer Limitations:** VIP Event Pass availability will end August 5, 2019 or when the VIP Event Pass offer has been depleted, whichever comes first. The VIP Event Pass is available on a first-come, first served basis, while supplies last, as determined by Company in its sole discretion. Limit of one (1) VIP Event Pass per eligible Participant. The VIP Event Pass is non-transferable and can only be used as specified by Company and/or the Cruise Event Producer/ Operator during the Cruise. The VIP Event Pass has no associated cash value and cannot be transferred, sold, bartered or redeemed for cash. If a Participant is unable to join the Cruise for any reason, such Participant is not allowed to sell, transfer or exchange their VIP Event Pass to another person, except in the sole and absolute discretion of Company. The Cruise will run from October 26, 2019 to November 2, 2019 ("**Cruise Date**"). Company reserves the right to determine the date and time of the Blueprint Cruise Event(s) within the Cruise Dates. Participants will be informed of the exact dates and times of the Blueprint Cruise Event prior to the Cruise departure. **Participants may be required to execute and return an affidavit of eligibility, release of liability, and except where prohibited, publicity release, following receipt of the VIP Event Pass.**

4. **Cruise Cancellation:** As the Reservation Incentive Program reward (i.e., the VIP Event Pass) is an on-board cruise reward, Company's obligation to provide any Participant with such reward is contingent upon the Cruise taking place, the availability of talent, and such Participant being on-board the Cruise ship during the Cruise event dates. Company reserves the right, in its sole and absolute discretion, to cancel the Cruise before final payment and you agree to hold harmless Company, Cruise Operator/Co-Producer, and all other entities involved with this Cruise and Blueprint Cruise Event for any out of pocket expenses (airfare, hotels, etc.) you may incur as a result of the cruise event cancellation.
5. **Event Conduct:** Recipients shall conduct themselves with due regard to the public conventions and morals. Recipients, while attending the event, shall not commit any act that will tend to degrade Company and/or the Cruise Operator or behave in a manner that is obnoxious or threatening, illegal, or that is intended to annoy, abuse, threaten, or harass any other person. Company and/or the Cruise Operator reserve the right to immediately revoke the VIP Event Pass and participation in the Blueprint Cruise Event, in their sole discretion.
6. **General Conditions:** Company reserves the right to cancel, suspend and/or modify the Incentive Program and/or the VIP Event Pass offer including but not limited to the Onboard Premium Events and Program. This may also include departure date or other related details on this Cruise. Company's rights in this paragraph also apply to Company's ability to modify the VIP Event(s) including, but not limited to, date and time of such events, personnel attending the events, and activities conducted at events. Company reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the process or the operation of Incentive Program.
7. **Release:** Participant's participation in the Incentive Program constitutes each Participant's consent to Company's and its agents' use of Participant's name, submitted images, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration, without expiration. Participants agree to release and hold harmless Company and its subsidiaries, affiliates, suppliers, distributors, advertising agencies, the Cruise Operator- Ron Oyer's Life Journeys, and each of their respective parent companies and each company's officers, directors, employees, insurers and agents (collectively, the "Released Parties") from and against any claim or cause of action, including but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Incentive Program and the Incentive Program Events.
